II. OBJECTIVE

1. Promoting running as the simplest form of exercise.

2. Promotion of physical activity and a healthy lifestyle, with behavior prevailing restrictions and safety rules during the prevailing pandemic.

III. DATE AND PLACE

1. 17-24 September 2020.

2. The official date of the competition is September 20, 2020.

3. Distance 5 km.

4. The competitor may cover the distance in any terrain, while maintaining traffic regulations and recommendations of the Ministry of Health.

IV. TIME LIMIT

1. There is no time limit for the participants.

V. PARTICIPATION AND APPLICATIONS

1. Entries can be made through the Datasport web portal available at www.datasport.pl or www.bieglechitow.pl on August 11 - September 16, 2020.

2. Only people who are on will be 18 years old.

3. The condition for participation in the race is correct completion of the form registration and payment of the entry fee. Filling the form registration and payment of the entry fee referred to in point VII / 1.

4. After registering and registering the payment, the participant will be given the opportunity download the starting number in a PDF file. It's not required, but it's nice seen running with the starting number.

5. The organizer allows wheelchair competitors to start.

VI. RULES

1. The participant registers for the race on the website www.datasport.pl or www.bieglechitow.pl

2. Each participant has a distance of 5 km to cover. The indicated distance can be beat on any days, only from September 17 2020, 0:00 to 24 September 2020, 23:59.

3. The distance must be covered in a single run of 5 km.

4. Time and distance will be measured through the GPS recorder application for a phone with Android or IOS, available at www.datasport.pl.

It is also allowed to classify competitors after verification of the sent track a run in the form of GPX or TCX recording. The track of the run as a file belongs upload to the results system. The appropriate button is next to the list results along with instructions on how to obtain files from more famous programs for runners like Endomondo, Garmin and Strava.

5. The company is responsible for the technical side of measuring time and recording the results Datasport. Correspondence related to registration and results at: biuro@datasport.pl.

6. There is no time limit for competitors.

7. It is not allowed to make breaks in the time registration during the climb competition route. Breaks in time recorded with Endomondo programs or Garmin will be automatically canceled while loading to the results and a running time will be the time between the physical time of the first one and the last reading.

8. The covered route should be as comfortable, flat and paved as possible because there will be no hills or other difficulties of the route influenced the time recorded in the results. They will not be used no conversion factors.

9. Results not recorded reliably will not be published.

10. You can enter the race only once.

11. Incomplete applications will not be taken into account.

12. The organizer will successively verify and update the results and published them on the website www.datasport.pl.

13. Documentation is the condition of receiving the selected package running min. 21,097 km.

14. Packages will be sent at the organizer's expense within 4 weeks of completion run, i.e. until October 23, 2020.

VII. FEES

1. Each participant of the run bears the costs of the entry fee, which is PLN 80 under this fee, the participant will receive a package with a starting numer and an occasional diploma (downloadable in PDF file) and a medal and a technical T-shirt in a limited version of the 43rd Lechity Run.

2. The starting fee should be made via electronic payments immediately after online registration.

3. A participant who has paid for the starter package for this year's Five Lechites and not sent an e-mail to the organizer with the information that the fee would be transferred to the next one year, the return fee or the shipping t-shirt will be automatically credited to The five Lechites virtual edition.

4. When shipping abroad, the package price increases by PLN 50.

5. Participants automatically rewritten for virtual editing as they wish in order for their packages to be sent abroad, they must write an email to the organizer (biuro@klubaltom.pl) with such information and make an additional fee shipping 50 PLN.

6. Shipment of starter packages will be carried out to the address provided by the participant in the form. The organizer is not responsible for undelivered items shipments due to an incorrect or incomplete address. In case of return

The organizer reserves the right, as well as its related entities, to conduct interviews with each participant, take photos and / or filming, using names and surnames, image, voice and others materials originating from or related to participation in the run for the needs advertising, promotional, as well as the possibility of their use on the Internet or radio and television broadcasts and for any other commercial needs with the right to modify them.

4. The organizer reserves the right, as well as related entities, to free use of any photos sent by participants, film materials, interviews and recordings that can be free of chargé placed on selected electronic carriers, catalogs and media: television, radio, newspapers, magazines, websites for the needs advertising and promotional. Do you have to provide personal data?

How long will your personal data be processed?

Your data will be processed during the period of using the datasport.pl registration website and participation in the runs organized by KS Altom, for which you subscribe via the Website. After the end of this period, your data will still be stored for purposes resulting from legal provisions (especially tax and accounting) as well as counteracting fraud and abuse and pursuing any claims arising from the concluded contract. Some of your data (especially those found in the race results) may be also processed after this date for statistical and archival purposes.

Who will be the recipient of personal data?

Your personal data will be disclosed to the Administrator's employees, associates and subcontractors in to the extent necessary to achieve the aforementioned purposes of personal data processing. Letters start-up and results, containing basic personal data, will be publicly available, including published on gear website.

What rights do you have in relation to the processing of your personal data?
